In accordance with ICAO Doc 9574 - Manual on a 300 m (1 000 ft) Vertical Separation Minimum Between FL 290 and FL 410 Inclusive provisions, and CAR/SAM Planning and Implementation Regional Group (GREPECAS) Conclusions as adopted, I wish to invite your Administration/Organization to participate in the Fifteenth Meeting of the GREPECAS Scrutiny Working Group (GTE/15) to be convened at the ICAO South American (SAM) Regional Office, Lima, Peru, from 16 to 20 November 2015.

Please note that the Scrutiny Working Group (GTE) was established under the GREPECAS framework, in support of the implementation of Reduced Vertical Separation Minimum (RVSM) in the CAR/SAM Regions. To this end, the main objective of this meeting will be to perform risk analysis of Large Height Deviations (LHDs) and their impact on the Target Level of Safety (TLS) in Reduced Vertical Separation Minimum (RVSM) airspace in order to issue the relevant risk mitigation recommendations to reduce such events, in the interest of safeguarding safety.

State's focal points for LHD, Air Traffic Service (ATS) inspectors, air traffic controllers, pilots, supervisors of States and Territories of the ICAO CAR/SAM Regions experts of the Regional Monitoring Agency (CARSAMMA), as well as representatives of invited international organizations are expected to attend. The working language of the meeting will be Spanish, however, simultaneous interpretation will be provided only if sufficient participants of English speaking States provide timely registration.
