Overview of ICAO assembly

- ✈️ comprised of all Member States of ICAO
- ✈️ meets not less than once in three years and is convened by the Council
- ✈️ The Assembly has numerous powers and duties:
 - ✈️ elect the Member States to be represented on the Council;
 - ✈️ examine and take appropriate action on the reports of the Council and decide any matter reported to it by the Council; and
 - ✈️ approve the budgets of the Organization.
- ✈️ the Organization's sovereign body which establishes the worldwide policy of the Organization for the upcoming triennium.

Overview of ICAO assembly

- Reviews in detail the work of the Organization in the technical, administrative, economic, legal and technical cooperation fields.
- Has the power to approve amendments to the *Convention on International Civil Aviation* (Chicago, 1944), which are subject to ratification by Member States.

39th Session of the ICAO Assembly

- ✈ Member States wishing to submit proposals for the addition of items should do so by **18 August 2016**.
- ✈ For a Member State wishing to propose a new initiative or project activity that has budget implications for the Organization, it would be required to include a cost estimate for its proposal. Such Member State is encouraged to work with the Secretariat in developing the cost estimate and submit its proposal before **1 June 2016**, to enable the Council to consider and then decide if the proposal should be included in the draft budget submission.

39th Session of the ICAO Assembly

About the Assembly

The ICAO Assembly is the Organization's sovereign body. It meets at least once every three years and is convened by ICAO's governing body, the Council.

Registration

ICAO's 191 Member States and a large number of international organizations are invited to the Assembly, which establishes the worldwide policy of the Organization for the upcoming triennium.

During Assembly Sessions, ICAO's complete work programme in the technical, economic, legal and technical cooperation fields is reviewed in detail. Assembly outcomes are then provided to the other bodies of ICAO and to its Member States in order to guide their continuing and future work, as prescribed in Article 49 of the [Convention on International Civil Aviation](#).

Each Member State is entitled to one vote on matters before the Assembly, and decisions at these Sessions are taken by a majority of the votes cast – except where otherwise provided for in the Convention.
