- assist principal air navigation services inspector to develop Primary Aviation Legislation to regulate Air Traffic Management and Search & Rescue (SAR) in Botswana
- Assist principal Air navigation services inspector (PANSI) to develop Required Operating Regulations for the Basic Aviation Legislation and amend as necessary to maintain required safety in the provision of Air Traffic Management and SAR in Botswana
- Perform all activities necessary to assist the PANSI in monitoring implementation of relevant SARPS contained in ICAO Annex 2, Annex 5, Annex 11 and Annex 12 in Botswana and update as necessary.
- Publish Guidance Materials and other necessary Documents issued by ICAO related to Air Traffic Management, and SAR inspectorates in Botswana and update as necessary.
- Identify and advise the training needs of the incumbent and the staff working under the incumbent to the PANSI
- Review all Manuals, Written Procedures and Handbooks issued by the ANS directorate with regard to ATM/SAR and update when required.
- Identify and advise PANSI the relevant guidance and reference materials, documents, annexes and other useful publications relating to ATM and SAR, which should be available in the ANS directorate.
- Take necessary action to certify Air Traffic Service Providers in Botswana in accordance with applicable regulations Standards, written procedures and other relevant directives issued by the CAAB.
- Take necessary action to issue, renew, amend, suspend or cancel Air Traffic Service provider Certificates as the case may be.
- Maintain continued surveillance/Safety Oversight on Certified Air Traffic Service Providers and SAR facilities in Botswana in order to ensure that they maintain required safety standards specified by the CAAB.
- Follow proper procedures to take enforcement actions in accordance with available regulations in case of safety violations made by the Air Traffic Service Providers.
