# The Bahamas: Aviation Policy Reforms and Infrastructure Development



Air Transportation Reform Program (PBL) (US\$ 50 million): The objective of the program was to promote the development of safe and efficient air transport in the Bahamas that complies with international standards.



Airport Infrastructure Project (US\$ 35 million): The main objective of the program is to contribute regionally and globally to the sustainable integration of The Bahamas through secure air transport infrastructure improvements in the Family Islands (FI) airports.



Financial support in the technical cooperation program in the Bahamas before the audits: sponsoring ICAO consultants and staff.

#### Event: Developing a more robust aviation sector in the Caribbean



July, 2015 - IDB organized an aviation sector workshop in the Caribbean (Bahamas).



The participants identified the strengthening of regulatory frameworks and the improvement of airport infrastructure as the main areas of collaboration.

# Opportunities for the region

### Regional Public Goods (RPGs)



Each year, the IDB solicits proposals from the region to finance projects that promote RPGs by means of collective action.

Open for proposals every March.



The range of financing is between USD 500,000 to 750,000 to be executed in max of three years.



#### **Mandatory requirements:**

- (1) Most of applicants have to be IDB members;
- (2) Proposal/Document explaining the intervention;
- (3) A proposal needs to include counterpart resources from the participating countries. The contribution can be in cash and/or in-kind.
- (4) Request letters from the authorities involved.
