2. Discussion

- 2.1 In response to the conclusions indicated above, information has been presented to the States on the importance of promoting their air navigation services, taking into account the safety and quality of their services.
- 2.2 Support air navigation services, taking into account the new requirements of the ICAO annexes and their amendments, to ensure that the information complies with the established requirements and to promote the implementation of new capacities to support the States and to obtain regional benefits is very important.

- 2.3 Following implementation requires special attention for Eastern Caribbean States:
 - 1. Improve meteorological information
 - 2. Support PBN implementation
 - 3. Support Search and Rescue operation
 - 4. Improve use of data surveillance information in all flight phases
 - 5. Stablish or update contingency plans
 - 6. Development future ANS project according with national and regional needs under the new GANP version.
- 2.4 States must take into account their local needs, their interoperability with adjacent States to meet regional requirements and already established goals, and update their air navigation plan taking into account their development for at least the next 10 years.
