UNITING AVIATION

ICAO Highlighted Items for Consideration

- ★ Contingency Plans
 - ★ States should have contingency plans that address ANS, Airports, Safety and Security
 - ★ implementation in the event of disruption to ATS with the assistance of ICAO as necessary (Annex 11)
 - ★ coordination with IATA indicated that numerous NOTAMs were providing insufficient information on restrictions/reduction in ATS, or restrictions appeared overzealous
- ★ State Letter ref. **20/47** issued highlighting obligations to Annex 9 and Annex 11 and for States to review restrictions and to consider the following operations:
 - ★ aircraft in a state of emergency;
 - ★ overflights;
 - ★ operations related to humanitarian aid, medical and relief flights;
 - ★ alternate aerodromes identified in the flight plan (including those being used for extended diversion time operations (EDTOs);
 - ★ technical landings where passengers do not disembark;
 - ★ cargo flights; and
 - ★ other safety-related operations
- ★ The NACC and SAM Regional Offices and LACAC sent out the following letters to reach out to all NAM/CAR/SAM States and Territories:
 - ★ Letter ref. E.OSG NACC82400 on Economic Sustainability of Civil Aviation in Latin America and the Caribbean
 - ★ Letter ref. E.OSG NACC82426 on Statement of the Civil Aviation Industry in Latin America and the Caribbean

ANS

- The safe operation of the airspace and all its elements will be daunting for many of NACC States depending on the recovery of operations

AGA

- Airport challenges regarding the closing of airport operations by government authorities rather than by civil aviation authorities
- Development of an ICAO Sample Checklist for quick checks by airport regulators for resuming operations after an extensive lockdown/reduced operations period

ICAO, ACI, CANSO, IATA, TIACA, WFP and WHO have worked in close cooperation in the development of this single source for aviation-specific guidelines with the objective of ensuring appropriate planning and action at all levels in order to mitigate the effects of a human outbreak.

Ongoing Actions and Considerations of Support Operational And Travel Restrictions

- ★ Special flights during the COVID-19 outbreak
- ★ Humanitarian flights are covered by Standard 8.8 in Annex 9
- ★ Cargo flights, especially medical cargo, are also covered in Annex 9, by Standard 4.27
- ★ Repatriation flights of nationals to their homeland: Annex 9 Standard 8.8, relates to the facilitation of the entry into, departure from and transit through territories of aircraft engaged in relief flights
- ★ States taking extraordinary measures to protect their borders (double-edge effect)
- ★ Such flights and medical flights can be ad hoc diplomatic flights falling under Chapter 2 of Annex 9, and these can be disseminated by a State Letter or Electronic Bulletin.

Recovery plans (short, medium and long term)

- ★ Develop Recovery Studies (ICAO NACC/SAM & LACAC efforts):
 - ★ Air cargo operation in the regions and the standards that facilitate its development.
 - ★ Studies allowing gauging the future demand of air transport passenger and cargo as well as eventual incentive mechanisms
- ★ ICAO Recovery Plan work document (possible recovery guidance -short, medium and long-term):
 - ★ Each State should play a primary role in the recovery of its own air transport through the implementation of globally-harmonized, efficient public policies and strategies
 - ★ Challenges faced by the aviation industry amid the COVID-19 crisis
 - ★ Issues likely to be encountered on the recovery path
 - ★ Key concepts for the preparation and implementation of recovery measures
