# Agenda Item 3: Review of Safety Information from RASG-PA Annual Safety Report - 3<sup>rd</sup> Edition

- 3.1 The Secretary briefed on the outcomes of the RASG-PA Annual Safety Report (ASR) 3rd Edition, in order to align the RASG-PA training strategy for 2013.
- 3.2 The Meeting was informed that the ASR presents analysis performed by the RASG-PA Annual Safety Report Team (ASRT) regarding aviation occurrences in the Pan American Region by extracting safety information collected from ICAO, Boeing, and IATA, and that the analysis of the reactive safety information showed that the three top fatal accident categories for the 2002-2011 period continues to be:
  - 1. Loss of Control In-flight (LOC-I)
  - 2. Runway Excursion (RE)
  - 3. Controlled Flight Into Terrain (CFIT)
- 3.3 The Meeting noted that the ASR also showed the following information:
  - 1. LOC-I and CFIT occurrences showed a decreasing trend.
  - 2. System-Component Failure/Malfunction (non-powerplant) (SCF-NP) occurrences showed an emerging trend.
  - 3. Unknown (UNK) occurrences showed an emerging trend.
  - 4. ICAO Universal Safety Oversight Audit Programme (USOAP) showed a low level of ICAO Standards and Recommended Practices (SARPs) effective implementation in some States in the Region; specifically, in the area of qualification and training of technical staff.
- 3.4 The Meeting acknowledged the relevance of the information provided to design the content of the seminars/workshops and to collect and post the appropriate and relevant training material on the RASG-PA website.
- 3.5 The Meeting agreed that there is a need to deliver more training in the Region, and that the support of the different stakeholders is key for the success of the activity.
- 3.6 The Secretary mentioned that the ICAO NACC Regional Office scheduled several seminars and workshops for 2013, among them the Accident and Incident Investigation Seminar, which will be held in Mexico by mid-year.
- 3.7 The Meeting noted that the representative of Volaris offered to sponsor training seminars/workshops in Mexico.

# Agenda Item 4: Review of RASG-PA Detailed Implementation Plans (DIPs) Associated with Training

# 4.1 RE/08: Guidance in Maintaining Runway in accordance with Annex 14

- 4.1.1 The Meeting was informed that the "Guidance for Maintaining Runways in Accordance with ICAO Annex 14," a DIP output related to runway maintenance guidance for airports in the Pan American Region prepared by ACI-LAC, was reviewed by ICAO Aerodromes and Ground Aids (AGA) experts.
- 4.1.2 Due to the difficulty to keep the above-mentioned document updated with current changes, the ICAO experts recommended that it would be more practical to use the guidance material developed by ICAO in this regard.

# 4.2 RE/09: Specific Training for Pilots and Air Traffic Controllers to avoid Unstabilized Approaches

- 4.2.1 The ALTA representative informed regarding the progress of a video to be used as self-training material. ALTA expects to have the draft ready by March 2013.
- 4.2.2 The ALTA representative asked Airbus about the possibility of using their facilities and simulator to film the video. The Airbus representative will coordinate with ALTA on the availability of the simulator as requested.
- 4.2.3 Another issue discussed was funding to develop the video. The Meeting considered that IATA and ALTA could provide some support; however, the issue would be elevated to the ESC.

# 4.3 RE/11: Develop Guidance Material and Training Programmes to Create Action Plans for Runway Safety Teams

4.3.1 The Secretary informed on the progress of the Runway Safety Team (RST) Implementation Toolkit as reported by the DGAC of Mexico, which will be presented at the PA-RAST/12 Meeting. The Toolkit will include the electronic checklist.

#### 4.4 CFIT/04: CRM/Situational Awareness for Pilots and Air Traffic Controllers

4.4.1 IFALPA informed that the initiative to develop a video was not feasible due to lack of funding and resources to adequately produce it. Development of a Toolkit was considered instead. This proposal will be discussed at the PA-RAST/12 Meeting.

# 4.5 Loss of Control Inflight (LOC-I)

4.5.1 The Meeting was informed that all the LOC-I DIPs were completed. However, the Secretary informed the Meeting that ICAO is working on a LOC-I Toolkit to be released in 2013.

- 4.5.2 The Secretary invited IFALPA to update the Pilot Monitoring Toolkit with recent information as published in the RASG-PA Annual Safety Report 3<sup>rd</sup> Edition.
- 4.5.3 Another issue discussed by the Meeting was the concept of Pilot Not Flying versus Pilot Monitoring. The Meeting agreed that there is need to adopt a single concept, considering that for a given air operator the two definitions exist according to different aircraft manufacturers.

# Agenda Item 5: Review and Assess the Available Aviation Safety Training Material related with RASG-PA Safety Enhancement Initiatives (SEIs)

- 5.1 The Meeting discussed the need to have more training organization participation in RASG-PA activities.
- 5.2 The Airbus representative informed that they have two different sites for material, one of them is private only for Airbus customers and the other is open to the public: www.airbus.com/company/aircraft-manufacture/quality-and-safety-first/safety-library/
- 5.3 The Meeting acknowledged that in the Airbus Safety Library link there are Briefing Notes, which have been developed to constitute a safety-awareness reference for all aviation actors, regardless of their role, type of equipment, and operation. They provide equal focus on Flight Operations (Volume 1), Cabin Operations (Volume 2), and Maintenance (Volume 3). The updated link will be added to the RASG-PA website.
- 5.4 The IATA representative informed that they are in the process of creating an ATC Phraseology Course. They are seeking funding to develop it. The initial aim of the course is to train the trainer in order to disseminate it throughout the Region.
- 5.5 The Meeting agreed with this initiative and asked the champions to prepare a business case to be presented to the ESC for consideration.
- The Meeting also agreed that this course should be part of the initial and recurrent training programme for pilots and air traffic controllers, and that the CAAs must have an oversight programme that enforces compliance with course delivery as well as use of proper aeronautical phraseology.
- 5.7 The Volaris representative informed that they support any training activity and offered their facilities in Mexico City, Mexico, to conduct any training as recommended by RASG-PA.
- 5.8 The Meeting acknowledged the great source of information and material available in Skybrary, Flight Safety Foundation, and U.S. FAA websites. These links are available on the RASG-PA website.
- In regard to Skybrary, the Meeting reviewed various toolkits available on this website with particular interest on the Stabilized Approach Awareness Toolkit for Air Traffic Control (ATC). The toolkit is aimed at raising air traffic controller awareness on the subject of stabilized approaches. It was developed jointly by the Civil Air Navigation Services Organisation (CANSO), the Flight Safety Foundation, EUROCONTROL and Cotswold Airport. The Meeting considered that it is a great aid and recommended that the link:

  www.skybrary.aero/index.php/Toolkit:Stabilised\_Approach\_Awareness\_Toolkit\_for\_ATC be included on the RASG-PA website.

- 5.10 The Airbus representative informed that they delivered the following courses in 2012 in the Region:
  - XG-14 OPERATOR SMS COURSE Mexico City, Mexico 3-6 July
  - XG-15 FDA SAFETY ANALYST COURSE Mexico City, Mexico 9-11 July
- 5.11 Airbus also informed that the organizations in attendance were: DGAC Mexico, ICAO-NACC, Interjet and Volaris. The 2013 schedule for Latin America is in the planning process at this time.

# Agenda Item 6: Update about the RASG-PA Request to ICAO SAFE Fund for Training

- 6.1 The Secretary informed that the funding request to the ICAO SAFE Fund for delivering the proposed RASG-PA seminars/workshops was not approved at this time.
- 6.2 There was disappointment with this outcome considering that the RASG-PA training programme addresses regional training needs to enhance safety.
- 6.3 The Meeting agreed that RASG-PA must try again to get funding for training in 2013.

# Agenda Item 7: ASTT Work Programme for 2013

# 7.1 Criteria for Selecting Locations for Workshops/Seminars

- 7.1.1 The Meeting considered that RASG-PA, as part of its regional safety activities, must deliver regional seminars/workshops in the Pan American Region free of charge, and due to resource constraints, must adopt criteria to select workshop/seminar locations.
- 7.1.2 The Meeting reviewed the criteria adopted by RASG-PA in 2012 for selecting States for delivery of seminars/workshops. The Meeting acknowledged that some States expressed their disagreement with these criteria even though it was approved at the RASG-PA/04 Annual Plenary Meeting.
- 7.1.3 Therefore, the Meeting agreed that RASG-PA Secretariat will send an invitation to all States to offer them an opportunity to host a seminar/workshop or any training activity promoted by RASG-PA in 2013, in order to avoid any disagreement regarding the criteria for selecting locations.

#### 7.2 Other Activities

- 7.2.1 Based on the safety information provided by the RASG-PA Annual Safety Report  $-3^{rd}$  Edition, the Meeting considered that the programme of the seminars/workshops is aligned with regional needs.
- 7.2.2 The Meeting was informed that Brazil had asked during the ESC/15 Meeting to include a Performance-Based Navigation (PBN) module as a Safety Enhancement Initiative (SEI) in the seminars/workshops programmes.
- 7.2.3 The Meeting considered that the delivery of safety training during any RASG-PA meeting would be very useful, considering that many of the experts from different States/Organizations would be on-site and the seminars/workshops add value to the event. The training events could become an incentive for States to host.
- 7.2.4 The Meeting suggested, as a minimum, the delivery of safety training and seminars/workshops in 2013 as follows:
  - Mexico, Mexico City, first quarter, ICAO NACC Regional Office
  - United States, Miami, 24 May, IATA Regional Office
  - Costa Rica, San Jose, 25 June, 4<sup>th</sup> Pan American Aviation Safety Summit
  - Peru, Lima, third quarter, ICAO SAM Regional Office
- 7.2.5 The Meeting considered that the outcome of the Information Analysis Team (IAT) would be useful for preparing training programmes for the Region.

# **Agenda Item 8: ASTT Train the Trainer (TTT) Project**

- 8.1 The Meeting discussed that due to the current limitation of resources, and in order to disseminate training throughout the Region, it would be necessary to look for an alternative way of doing business.
- 8.2 The Secretary proposed that RASG-PA could develop a Train-the-Trainer Programme to comply with this objective.
- 8.3 The Meeting agreed with the proposal, and the IATA representative offered to lead this initiative with the support of ALTA and IFALPA.
- 8.4 The IATA representative mentioned that they have a Train-the-Trainer course that could be adapted for use in this initiative.
- 8.5 The IATA, ALTA and IFALPA representatives will coordinate activity with the RASG-PA Secretariat in order to launch the initiative during the first quarter of 2013.

# Agenda Item 9: ASTT/05 Meeting

# 9.1 Logistics

- 9.1.1 The Meeting agreed to convene the ASTT/5 Meeting in December 2013, in Miami, United States, hosted by ALTA.
- 9.1.2 The Meeting also agreed that another meeting may be planned, if needed, and that the use of virtual meetings to review and update the ASTT work programme may be scheduled, as required.

# 9.2 Agenda

- 9.2.1 The Meeting was informed by the Secretariat that the draft agenda will be coordinated with the ASTT members and circulated by the RASG-PA Secretariat as part of the invitation letter to the ASTT meeting.
- 9.2.2 The Secretary encouraged the ASTT members to review the draft agenda upon its circulation and propose any changes or provide inputs, as required, in a timely manner.

#### Agenda Item 10: ASTT Recommended Actions for the RASG-PA/ESC

- 10.1 The ASTT Meeting invites RASG-PA/ESC to note the progress of ASTT activities as follows:
  - 1. Training activities delivered by the ASTT in 2012:
    - Mexico City, Mexico, 30-31 January, ICAO NACC Regional Office
    - Bogota, Colombia, 21-22 June, in the framework of the Third Pan America Aviation Safety Summit
  - 2. The Approach and Landing Accident Reduction Toolkit (ALAR) Release 5.0 courtesy of Flight Safety Foundation (FSF) was uploaded on the RASG-PA website for free downloading by the aviation community.
  - 3. SMS and FDA Safety Analyst training provided by Airbus in the Region in 2012.
  - 4. Airbus provided a link to its Safety Library, which has been added to the RASG-PA website.
  - 5. Airbus hosted the ASTT/04 Meeting.
  - 6. Proposed RASG-PA training activity planned for 2013:
    - Mexico City, Mexico, first quarter, ICAO NACC Regional Office
    - Miami, United States, 24 May, IATA Regional Office
    - San Jose, Costa Rica, 25 June, 4<sup>th</sup> Pan American Aviation Safety Summit

  - 7. IATA will host a seminar/workshop in Miami, United States.
  - 8. Volaris offered to host safety training events in Mexico City, Mexico.

  - 10. Continue to seek additional funding for RASG-PA regional safety training activities and initiatives from the ICAO SAFE fund.
  - 11. Include the Skybrary link about Stabilized Approach Awareness Toolkit for ATC developed by the Civil Air Navigation Services Organisation (CANSO), the Flight Safety Foundation, EUROCONTROL and Cotswold Airport on the RASG-PA website.
  - 12. RASG-PA Secretariat will contact all the States to offer the opportunity to host a seminar/workshop or any training activity in 2013.
  - 13. The ASTT will schedule delivery of safety training during all RASG-PA meetings.
  - 14. A PBN module will be added to the seminars/workshops programmes as a safety enhancement initiative.

- 15. IATA, supported by ALTA and IFALPA, will lead the Train the Trainer Programme to increase the presence of RASG-PA training activities in the CAR/SAM Regions to enhance safety.
- 16. RASG-PA Project GSI-3A Proposal for Amendment to aeronautical legislation to protect safety information Sources has planned two CAR/SAM seminars/workshops:

• ICAO SAM Regional Office: first semester

• ICAO NACC Regional Office: second semester

# **Agenda Item 11:** Other Business

- 11.1 The Secretary informed that coordination is on-going with COCESNA/ACSA to deliver a bilingual CAR/SAM Regional seminar/workshop in 2013 on RASG-PA Project GSI-3A *Proposal for Amendment to Aeronautical Legislation to Protect Safety Information Sources*.
- 11.2 The initial plan is to deliver one seminar at the ICAO SAM Regional Office during the first semester and the other at the ICAO NACC Regional Office in the second semester of 2013.
