

Membership Regional Distribution



TRAINAIR PLUS™

Training challenges facing States

- Lack of harmonization of licensing requirements
- "Train Regionally" concept currently difficult to implement
- Lack of harmonization and standardization of curricula
- Non-recognition of certificates
- Insufficient resources (financial, human, material)
- Redundancy of training


