## **1. INTRODUCTION**

1.1. The scope of activities of the AFPP, as presented in section 2.2.3 of the Programme Document covers the following:

- a) *assist States' procedure and airspace designers in developing their procedures with priority for PBN procedures;*
- b) *assist States with Quality Assurance (QA) including flight procedure regulatory approval*
- c) *provide training course, refresher course and OJT to procedure designers, remotely, on-site or at the AFPP location;*
- d) *provide training course and OJT for QA including flight procedure regulatory approval;*
- e) *provide training course and OJT for operators approval for PBN operations*
- f) *assist States in PBN Plan implementation through operational assessment, business case, and activity planning for PBN Implementation*
- g) *assist States in developing PBN-related regulations*
- h) *develop procedures implementation for States that have no procedure design capability;*
- i) *assist States with data origination*
- j) *assist States with ground and flight validation;*
- k) *assist States in operators approval for PBN operations*
- l) *provide training course and OJT for ATC/ATM and operators about PBN flight procedures operations*
- m) *provide States with any other associated assistance as required.*

1.2 In developing the proposed 2015 AFPP Work Programme attached to this paper, the Secretariat took into account the above list of activities.

## 2. **DISCUSSION**

- 2.1. The AFPP Programme objective is to assist States to develop sustainable capability in the instrument flight procedure (IFP) domain so as to meet their commitments under Assembly Resolutions A37-11 for Performance Based Navigation (PBN) implementation and their obligations for the quality of their IFPs. This will be accomplished through training, assistance with quality assurance, procedure design and access to IFP-related automation solutions.
- 2.2. The Work Programme is therefore tailored to these objectives and will be executed through a series of seminars, workshops and training courses, addressing the items described in section 1.1. above.
- 2.3. The seminar/workshops and training courses would be organized in Dakar, Nairobi or upon invitation from any other Member State, while trying to maintain a geographical balance in the Region. The Flight Procedures Design courses will be organized in the AFPP Dakar facilities due to availability of equipment and course material.
