1.1 The PBN Task Force in Nairobi, 4-6 December 2009 adopted the following Conclusion:

Conclusion 2/15: AFI PBN Action Plan.

1.2 The above Task Force Conclusion was endorsed by the ATS/AIS/SAR/SG/10 meeting Dakar, 12-15 May 2009 and formulated Decision 10/07: AFI Regional PBN Performance Objectives and Action Plans as follows:
