Subject: Sixteenth Meeting of the AFI Planning and Implementation Regional Group (APIRG/16), Kigali, Rwanda, 19-23 November 2007

Action Required: Reply to paragraphs 5 and 6 not later than **15 October 2007**

Sir/Madam,

1. I have the honour to inform you that the AFI Planning and Implementation Regional Group (APIRG) will hold its Sixteenth meeting from 19 to 23 November 2007 in Kigali, Rwanda, at the kind invitation of the Government of that State. The tentative agenda and explanatory notes for the meeting are at **Attachment A** to this letter. The meeting will be conducted in English and French and documentation will be issued in these two languages. Your Administration is kindly invited to participate in this meeting.

2. As you may recall, at its Fifteenth Meeting, APIRG made a number of decisions and adopted some conclusions. The report of that meeting was forwarded to you by the ICAO Regional Directors accredited to your respective States. Subsequently, various actions were taken by the Air Navigation Commission and ICAO Council. As an important part of the Agenda, the APIRG/16 meeting will review and consider the status of implementation of APIRG/15 Conclusions and Decisions as well as outstanding Conclusions and Decisions of APIRG.

3. The Council and Air Navigation Commission have in the past emphasized the need and importance of members of ICAO bodies to endeavour to meet their obligations by attending meetings of the respective bodies. Therefore, they commended APIRG members and States of the Region for the efforts made in attending APIRG meetings. It is therefore expected that all members of APIRG will attend this particular meeting. **Attachment B** gives the list of members of APIRG as approved by the Council and **Attachment C** the information bulletin and a list of suggested hotels in Kigali. However, non-members with specific interests in the subjects to be addressed by the meeting may also attend.

4. Documentation for the meeting is being prepared based on reports of contributory bodies; namely, the Eighth Meteorology Sub-Group (MET/SG/8), Ninth Air Traffic Management Sub-Group (ATM/SG/9), the Second Communications, Navigation and

Working Papers received after the above date will be distributed only in the language in which they are received, without translation, due to financial constraints of the Organization and directives of Council to minimize such costs (APIRG Decision 11/23 refers).

6. Kindly advise me of your participation at the APIRG/16 Meeting as soon as possible but in any case not later than **15 October 2007**, giving the names and functions of all participants from your State.

Agenda Item 7: Technical Cooperation

The meeting will also be apprised of progress in the Implementation of the various sub-regional cooperative projects for improvement of aviation safety oversight in the region and on-going efforts to create Regional Safety Oversight Organizations (RSOOs).

The meeting under this agenda item will review the terms of reference and working arrangements of the Group, including its Procedural Handbook and their relevance in view of the current developments (introduction of the ICAO Business Plan) and other emerging issues in the air navigation

1. SITE OF THE MEETING

1.1 The meeting will be held at the Hotel Des Mille Collines next to Central Bank of Rwanda

1.2 REGISTRATION

Registration of participants will be on Sunday, 18 November, 2007 from 1400 to 1900 hours.

2. HOTELS

2.1 Participants are requested to make their own hotel reservations. A list of recommended hotels is attached. When making hotel reservation, participants should state that they are attending APIRG/16, an ICAO meeting.

3. VISA

3.1 All travellers arriving in Rwanda should have a valid passport. Participants are advised to provide the following details to the Rwanda Civil Aviation Authority caa@rwanara1.com, Fax +250 582609 with a copy to the ICAO Regional Office, Nairobi, Kenya (ICAO@icao.unon.org Fax +254-20-7621092):

Participants from Mauritius, South Africa, East African Community (EAC) Member States and Democratic Republic of Congo(DRC) do not require entry visa to Rwanda.

Participants from other countries are required to pay US\$50 or US\$60 for the VISA.

Those participants who have Rwandese Embassies in their countries should apply for visas well in advance which will be issued to them upon presentation of documentation showing that the applicants are designated representatives to APIRG/16 meeting to be held in Kigali.

4. TRANSPORT

4.1 The Government of Rwanda will provide transport between Kigali International Airport, the Principal hotels and the Conference venue for all participants.

5. CLIMATE

5.1 The average temperatures during the month of November is 20°C, average minimum is 15°C and average maximum is 26 °C. The short rains occur from October to November. The average rainfall for November is 123mm.

6. SECURITY

6.1 The general security is good however, participants are expected to be vigilante at all times. More information will be provided during the meeting.

7. HEALTH

Malaria Risk

7.1 **Malaria** risk is predominantly due to *P. Falciparaum and* exists throughout the year in the whole country. Resistance to **Chloroquine and Sulfadoxine** has been reported. Recommended prevention: Prevention of mosquito bite plus use of mefloquine, doxycycline or atovaquone + proguanil chemoprophylaxis.

8. CURRENCY

8.1 The average rate of exchange for the Rwanda Franc is
1 US\$ = 546 RWF
1 Euro (€) = 742.4 RWF.

Participants are advised to exchange currencies at the Official Banks or Bureaux de Change.
