1. INTRODUCTION

1.1 The Provisional Agenda for the Eleventh Meeting of the Air Traffic Services/Aeronautical Information Service/Search and Rescue Sub-Group (ATS/AIS/SAR SG/11) and its explanatory notes were sent to States and concerned Organizations, as attachments to invitation letter Ref: ES AN 4/60 - 0095 dated 23 February 2010, and are presented at **Appendix A** to this working paper.

1.2 The meeting will recall that in arranging the convening of the ATS/AIS/SAR SG/11, note was made that there is a significant amount of work for the Sub-Group, which would have to be managed accordingly. APIRG 17 is scheduled to be convened in the first week of August 2010, and the Thirty Seventh Session of the ICAO Assembly is scheduled to be convened from 28 September to 8 October 2010 in Montreal, Canada.

1.3 In accordance with established practice within APIRG, the Meeting is to elect a Chairperson from among its members States, to conduct its business.

2. **DISCUSSION**

2.1 The invitation State Letter Ref: ES AN 4/60 – 0095 dated 23 February 2010 observed that there is a considerable amount of outstanding implementation work that emanates, *inter alia*, from the Special AFI Regional Air Navigation Meeting 2008 Recommendations, Conclusions from within the framework of APIRG and related commitments. Furthermore, this will be the second meeting of the Sub-Group since APIRG 16, before the APIRG 17 Meeting. Accordingly, it is essential that the meeting gives priority to achieving progress on outstanding work and reporting the same to APIRG 17, as opposed to developing new projects.

2.2 The meeting may wish to note that the above-mentioned observations and developments were taken into consideration in drafting the agenda and its explanatory notes.

2.3 In accordance with the provisions of the APIRG Handbook, in order to ensure the necessary continuity in the work and unless otherwise determined by special circumstances, the Chairman and Vice-Chairman of a sub-group should serve for an unspecified period of time. However, the Handbook also provides that members of a subgroup may at any time request the election of the chairman and/or Vice-Chairman to be included in the agenda of a meeting, and that elected officers may be re-elected.

The meeting will elect from among member of the Sub-Group, the Chairperson and Vice-Chairperson to administer its deliberations

Agenda Item 2: Follow-up on SP AFI RAN Recommendations, Conclusions and Decisions within the Framework of APIRG relevant to the ATS/AIS/SAR SG

The meeting will review and update action taken and be taken on Recommendations of the SP AFI RAN, review, update and as appropriate propose consolidation of the Conclusions and Decision formulated within the framework of APIRG

Agenda Item 3: APIRG Performance Objectives

The meeting will review Performance Objective initiated by the SP AFI RAN, update, and complete the same for consideration by APIRG 17

Agenda Item 4: CNS/ATM Coordination Issues

The meeting will consider issues referred for its action by the CNS SG and other CNS issues identified as requiring action by the ATS/AIS/SAR SG

Agenda Item 5: RVSM operations and Monitoring activities

The meeting will consider RVSM implementation issues including the POSC and take action as necessary

Agenda Item 6: Performance Based Navigation (PBN) and AFI ATS Route Network

The meeting will consider outcome of the Joint meeting of the PBN Task Force and the GNSS Implementation Task Force and take action on items which are relevant for the meeting

Agenda Item 7: ATS Safety Management Systems

The meeting will consider issues relating to the status of implementation of ATS SMS in the AFI Region and propose action to assist States implementation efforts. Furthermore, the meeting will review status of reporting related to hazards, incidents and unsatisfactory conditions affecting safety, and propose action to improve reporting, States' responses to reports and investigations.

Agenda Item 9: Search and Rescue (SAR) and Civil/Military Coordination

The meeting will develop specific action plans to implement the Performance Objectives developed by the SP AFI RAN with regard to implementation in the SAR field. The meeting will also be apprised on outcome of the Global Civil/Military Cooperation Forum at ICAO HQ in 2009, review issues relating to implementation in Civil/Military coordination and take action as necessary

Agenda Item 10: Transition to new ICAO Flight Plan content

The meeting will review the status of implementation in the States with regard to Amendment 1 to the 15 edition of Doc 4444. The meeting will be expected to establish a specific subsidiary body to coordinate States' efforts and facilitate harmonized Regional transition and approach to implementation.

Agenda Item 11: AIS/MAP issues

The meeting will review the outcome of the ATS/AIS/SAR SG/10 on AIS/MAP issues with a view to consolidate a list of Conclusions and Decisions to be presented to APIRG/17.
