- Agenda Item 1: Election of Chairman and Vice-Chairman of the Sub-Group**  
The Sub-Group will elect its Chairman and Vice-Chairman.
- Agenda Item 2: Review of APIRG Conclusions and Decisions**  
A review will be carried out on actions taken and progress made on the implementation of MET related conclusions and decisions of the APIRG.
- Agenda Item 3: WAFS and IAVW in the AFI Region**  
Under this agenda item, the meeting will review the status of the implementation of the WAFS and IAVW in the AFI Region in particular the activities of the SADIS Operations Group (SADISOPSG), WAFS Operations Group (WAFSOPSG) and IAVW Operations Group (IAVWOPSG). The meeting will integrate Conclusions and Decisions of the SADISOPSG/17&18, WAFSOPSG/6 & 7 and IAVWOPSG/6 & 7 of interest to the APIRG.
- Agenda Item 4: Review of the Recommendations of the AFI OPMET Management Task Force 4<sup>th</sup> and 5<sup>th</sup> Meetings (MTF/4 and MTF/5)**  
The meeting will review the recommendations in the reports of the AFI OPMET MTF/4 and 5 which will include the status of operation of the AMBEX Scheme, update of AFI SIGMET Guide, AFI ICD and OPMET related FASID Tables.
