The current CNS/ATM Plan spans the years 1995-2005. There is need to project the CNS/ATM Plan beyond 2005. The Sub-group will therefore review and update as necessary, the AFI CNS/ATM Implementation plan taking into account Agenda Items 2, 3, 4 and:

- a) the ICAO Global Air Navigation Plan for CNS/ATM Systems, (Doc 9750), Second Edition, 2002;
- b) the inputs from the ATS/AIS/SAR/SG/7 Meeting;
- c) the inputs from the COM/SG/6 Meeting;
- d) the inputs from the study on categorization of TMAs and aerodromes; and
- e) the CNS/ATM Implementation Plans of adjacent regions.

*Note*: Though they will have to be submitted to MET/SG, the results from the MET/SG Task Force on CNS/ATM would also be considered, if available.

#### Agenda Item 6: Review and update if required of the Surveillance Plan for the AFI Region

The meeting will review and update, if required, the Surveillance Plan for the AFI region. It will consider in this respect the results of the joint study by ASECNA and IATA on the categorization of TMAs and aerodromes.
