.1 The AFI Planning and Implementation Regional Group (APIRG) at its 13th meeting adopted a revised terms of reference and new work programme for the COM Sub-group, shown at **Appendix A** to this working paper. The APIRG also approved Eritrea and Ghana as new members of the COM/SG.

- 2.1 The main tasks of the COM Sub-group are the continuing and coherent development of the AFS plans and the identification, review and monitoring of deficiencies that affect COM services in the AFI Region.

TERMS OF REFERENCE AND WORK PROGRAMME FOR THE COM SUB-GROUP

1. Terms of reference

- a) Ensure the continuing and coherent development of the AFI Regional Implementation Plan for COM systems in the light of new developments;
- b) Identify, review, and monitor shortcomings and deficiencies that impede or affect the provision of efficient COM services and recommend appropriate corrective action.
