I have the honour to inform you that a seminar/workshop on the implementation of the Flight Procedures Programme for Africa-Indian Ocean region (AFI-FPP) will be conducted for the benefit of States in the AFI region, at the ICAO Regional Office in Dakar, Senegal, from 26-28 March 2014 to which your Administration/Organization is kindly invited.

This seminar/workshop is being organized pursuant to the ICAO Assembly Resolution A37-11 (Performance-based navigation global goals), October 2010, namely implementation of RNAV and RNP operations for en route and terminal areas and implementation of approach procedures with vertical guidance, and Resolution A38-7 (Comprehensive Regional Implementation Plan for Aviation Safety in Africa), October 2013, regarding the support to the establishment of the AFI Flight Procedure Programme (AFI-FPP) Office with seconded personnel and financial assistance as a matter of urgency to expedite the implementation of PBN in the region.

Current and future developments in satellite technology such as GNSS will, to a large extent, reduce the dependence of civil aviation on ground based navigation aids, as well as permit improvements in overall efficiency of Air Navigation Systems. ICAO PBN concept for flight procedures consolidated the previous ICAO GNSS concept and defines part of the future of Air Navigation.

The objective of this seminar/workshop is to provide essential training to operational and technical staff on PBN implementation and thus promote the further utilization of PBN in the AFI Region. The proposed agenda (Attachment A) will be supported by PBN experts in the areas of flight procedure design, aeronautical data collection and validation, airspace design, safety case development, quality assurance process, operational validation, regulatory processes for procedure approbation, and operational approval for aircraft operators.
