EXPLANATORY NOTES

Agenda Item 1: Adoption of the Provisional Agenda and Election of the Chairperson and Vice Chairperson

The meeting will adopt the agenda and elect from among its members the Chairperson and Vice-Chairperson to facilitate its business.

Agenda Item 2: Review of the outcome of the APIRG Extraordinary Meeting (10-11 July 2014)

The meeting will discuss outcome of the Extraordinary Meeting of APIRG (APIRG/EO), in particular the new organizational structure and working methods adopted in Lusaka in July 2014.

Agenda Item 3: Status of implementation of the Sub-Group work programme and related Task Forces/Working Groups as assigned by APIRG

The Sub-Group will review and update progress in the implementation of the Sub-Group's work programme and that of APIRG subsidiary bodies reporting to it.

Conclusions and Decisions consolidated by APIRG/19 from previous meetings of the Group will be reviewed and specific actions identified to implement them in the new working methodologies adopted by APIRG/EO..

Agenda Item 4: Linkage of remaining tasks of the Sub-Group with Aviation System Block Upgrades Modules (B0) and Regional Performance Objectives

Based on, *inter alia*, outcome of APIRG/19 and deliberations under Agenda Items 2 and 3 and 4 of the ATM/AIM/SAR SG/14, the meeting will link all remaining tasks of the Sub-Group with the Block 0 Modules the Aviation System Block Upgrades (ASBU) and Regional performance objectives, requiring implementation by States.

Agenda Item 5: Identification and development of projects based on Aviation System Block Upgrades (B0) and Regional Performance Objectives

The meeting will **identify, prioritize and define** specific implementation **Projects** to support implementation of ASBU Modules and Regional performance objectives taking into consideration the linking carried out under Agenda Item 5

In addition, the Sub-Group will propose (to APIRG) details on the composition of Project Teams to carry out the projects as contemplated by APIRG/EO.

Agenda Item 6: Review of the new Air Navigation Plan structure and the development of draft material for endorsement by APIRG

The Sub-Group will, pursuant to the 12th Air Navigation Conference (ANConf/12) in particular Recommendations 6/1 and 6/11 thereof, review material relating to Amendment of the AFI Air Navigation Plan as well its transition to new format, and propose adoption of the material to APIRG.

Agenda Item 7 : Any other business.

Any matters relevant to the ATM/AIM/SAR Sub-Group, not specifically provided for and covered under the above agenda items may be addressed under this agenda item, subject to procedural and other considerations related to the conduct of the meeting.
