1. Introduction

The AFI RAN meeting held in Durban, South Africa from 24 to 29 November 2008 formulated **Conclusion** 6/19: *Planning, implementation and operation of very small aperture terminal (VSAT) networks in the AFI Region* that calls for regular meetings of all AFI networks managers and reads as follows:

Conclusion 6/19: Planning, implementation and operation of very small aperture terminal (VSAT) networks in the AFI Region:

That

All entities involved with planning, implementation and operation of very small aperture Terminal (VSAT) networks in the AFI Region hold regular joint meetings under the auspices of ICAO regional offices for the purpose of harmonization and eventual realization of a seamless AFI communication network supporting all present and future communications, navigation, and Surveillance (CNS) Systems



Since Durban meeting, many actions have been undertaken by States/Organizations with ICAO regional Offices WACAF & ESAF support to implement this conclusion.

2. Discussion

- 2.1 The sixth CNMC meeting held in Lisbon, Portugal from 06 to 07 June 2016 reported on the activities undertaken by the AFI aviation community aiming to build an Integrated Aeronautical Telecommunication Infrastructure as, called upon by APIRG.
- 2.5 Since then, future actions have been undertaken by the VSAT network management committees to hold regular coordination meetings. The AFISNET management SNMC, the NAFISAT and SADC/2 supervisory bodies held their annual regular meetings which gave opportunity to address issues pertaining to the ground/ground and air/ground components of ATN and to continue the work on the definition of the conditions for the development of a robust sustainable telecommunication infrastructure based on the modernization of the existing VSAT Networks (AFISNET, CAFSAT, SADC/2, NAFISAT). The issues related to the performance of the networks (availability, speed of the ground segment to support ATN application such as AMHS and AIDC, surveillance data exchange) were considered by the meetings.
- 2.6 The projects related to aeronautical satellite communication to be implemented for ground/ground and air/ground services have been identified and will be presented to the APIRG IIM/SG scheduled to be held in Nairobi Kenya from 27 to 30 June 2017 and the outcome to be endorsed by the APIRG/21 meeting to be held in the last quarter of year 2OA7.
- 2.7 The projects take into account the outcome of the various coordination meetings on VSAT Networks (AFISNET, SADC/2, NAFISAT, CAFSAT...) and will align regional requirements pertaining to VSAT the with ICAO SARPs to be implemented in the framework of the ICAO Aviation System Block Upgrades (GANP Doc-9750).
