

### **Key Functions**

- ASSR Planning and coordination;
- Technical Liaison with ICAO, FAA, CASSOA and other international organizations;
- Quality Assurance of the Safety Oversight System and Processes;
- Enforcement of Kenya Civil Aviation Regulations (KCARS)
- Implementation and maintenance of SSP;
- Maintenance of the Safety/Technical Library.



#### **Roles of NCMC**

- Developing, updating and reviewing policies, standards, regulations and legislation relevant to safety & security oversight in line with ICAO standards and recommended practices, as well as other regional and international conventions of which Kenya is a member State;
- Interpretation and implementation of Aviation Safety Standards and Regulations; Provides continuous support and guidance to the Inspectorate Departments to ensure the proper interpretation and implementation of existing and new regulations;
- Incorporating appropriate safety standards and sound economic principles;
- Drive the Quality Assurance process for Oversight functions ;
- Coordinates matters related to planning for oversight activities;
- Ensures coordination, follow up and implementation of relevant issues related to ICAO, CASSOA, EAC, AFCAC, FAA and other organisations;
- Training inspectors and creating awareness on new and amended requirements as and when required;
- Supporting the resolution of safety concerns and enforcement of Civil Aviation Regulations



#### **OLF Management**

- Each Department has OLF access with their focal points
- Departments allowed to update CC, Self-Assessment and Upload Evidence
- CC/EFOD access limited to NCMC access only



## Challenges

- Effectiveness of Coordination
- Clarity of the role of NCMC
- View of NCMC scope limited to USOAP matters
- Reporting lines for NCMC



#### Lessons

- Without adequate authority NCMCs will be ineffective
- Inappropriate reporting lines affect effectiveness and thus State performance
- Lack of understanding of NCMC role affects
  performance
- Need for training and sensitization of DGs and Directors of Safety on USOAP and its working arrangements



#### Recommendations

- ICAO to provide guidance to States on:
  - Expectation on NCMCs position in the organisation (scope and depth);
  - Functions of NCMCs
  - Regular meetings
- Sensitization of Directors General on ICAO expectations with regard to NCMC role
