4.3 REDUCTION IN THE USAGE OF FREE TEXT MESSAGES

SUMMARY

This paper seeks to update the meeting on progress made on the compilation of frequently used Free Text Messages in the SAT Area

1. INTRODUCTION:

1.1 Following up from the work programme of SAT/12 the Go-Team was reconstituted by SAT/FIT/13 with Ghana as the Lead with the under listed activities to be performed:

- a) All ANSPs Focal Points and users to send to the Team Lead their frequently used Free Text Messages:
- b) Go-Team to review and Consolidate such compilation in the SAT and EUR/SAM corridor;
- c) Go Team to send to IATA the consolidated list of Free Text Messages for comments and feedback

 d) Go Team to update and submit t ICAO the final list for consideration into the GOLD MANUAL and propose amendment to DOC 7030 Regional Supplementary Procedures.

2. DISCUSSION

- 2.1 The Lead sent emails to the focal points of the various ANSPS soliciting information on their frequently used Free Text Messages but sadly, only South Africa responded.
- 2.2 It must be noted however that the other states that responded sent messages that were already in the UPLINK BOX of the ATM equipment.
- 2.3 Go Team could not review nor consolidate the compilation since the response from the States were not adequate.
- 2.4 Go Team could not send the consolidated messages to IATA since the response was not forth coming.
- 2.5 No list was sent to ICAO due to the previously listed reasons
