This paper presents the AFI Air Navigation Reporting Forms (ANRF) which were introduced as part of ASBU implementation measures and adopted by APIRG in order to provide Performance Targets and Performance Indicators and tools to guide States in the implementation of the various ASBU modules. The ANRF enables States to provide implementation updates of air navigation modernizations and improvements to ICAO for consolidation into regional and global reports.

1. INTRODUCTION

1.1 Air Navigation Report Form (ANRF) is the revised version of Performance Framework Form that was being used by Planning and Implementation Regional Groups (PIRGs)/States until now. The ANRF is a customized tool for Aviation System Block Upgrades (ASBU) Modules which is recommended for application for setting planning targets, monitoring implementation, identifying challenges, measuring implementation/performance and reporting. If necessary, other reporting formats that provide more details may be used but should contain as a minimum the elements described in this ANRF template.

2. DISCUSSION

2.1 The Secretariat believes that many States have implemented or at different stages of implementation of requirements stipulated in the AFI Air Navigation Plan and AFI Air Navigation System Implementation Action Plan. However, many States have not been reporting their navigation activities which are either implemented or planned in line with ASBU.

2.2 Due to the lack of information or data from States, and unlike other ICAO regions, the AFI Region has not published a regional status of implementation of the ASBU Modules.

2.3 The set of ANRFs which were adopted by APIRG to be used by State in report status of ASBU implementation is attached as **Appendix A** to this report.

3. ACTION BY THE MEETING

3.1 The meeting is invited to:

- a) Note and be conversant with the AFI ANRF, review the minimum performance matrixes and if necessary include additional matrixes;
- b) Note the full list of ANRF attached as **Appendix A** to this working paper and urge States to fill and return completed ANRF to their accredited ICAO Regional Office by 30 September 2020.
- c) Consider and propose additional actions to facilitate annual reporting of air navigation upgrades, improvements and modernization, in particular information of implemented ASBU modules.
