**1. INTRODUCTION**

- 1.1 The Twenty-fourth Meeting of the AFI Planning and Implementation Regional Group (APIRG/24) and the Seventh Meeting of the AFI Regional Aviation Safety Group (RASG-AFI/7) were held virtually from the 1<sup>st</sup> to the 8<sup>th</sup> of November 2021. Two joint sessions were convened (APIRG-RASG-AFI) on the 1<sup>st</sup> and 8 November 2021.
- 1.2 The APIRG/24 meeting adopted twenty-five (25) Conclusions and twenty-six (27) Decisions. In accordance with the RASG-AFI and APIRG, actions are recorded in the form of Conclusions and Decisions that are defined as follows:
  - a) Conclusions deal with matters which, in accordance with the Groups' terms of reference, merit directly the attention of States, or on which further action is required to be initiated by the Secretary in accordance with established procedures.
  - b) Decisions relate to the internal working arrangements of the Groups and their subsidiary bodies.

## 2. DISCUSSION

- 2.1 During its deliberations, the APIRG24 meeting recognized and appreciated the progress made so far in the coordination and conduct of IIMSG activities, including the status of the implementation of Conclusions and Decisions relating to the IIMSG.
- 2.2 The meeting acknowledged the challenges faced when implementing these Conclusions and Decisions and requested the Secretariat to explore other means to increase the participation of States in the IIMSG related activities. In addition, States and Organizations were urged to embark on the effective implementation of the outstanding Conclusions and Decisions of the IIM/SG4 and other previous meetings
- 2.3 All the outcomes of the IIMSG4 meeting were reviewed by the APIRG24 meeting and Conclusions and Decisions related to the IIMSG were formulated. The status of implementation of the Conclusions and Decisions in the MET, CNS and AIM areas is as attached in **Appendix 1**.
