

CURRENCY, CREDIT CARDS AND BANKING SERVICES

- 7.1 The national currency is the Fiji Dollar (FJD). The current rate of exchange for USD is approximately USD 1= FJD 2.03 in banks or exchange agencies. Foreign currency can be changed at banks, foreign currency bureau or hotels. Banks in major centres are open from Monday to Friday from 0900 to 1600 hours.
- 7.2 All major international cards are generally accepted in hotels, shops and restaurants.

WEATHER AND LOCAL TIME INFORMATION

7.3 In May, the daytime temperature in Nadi ranges from 21 °C to 31 °C, with average humidity of 80% (very humid). Fiji local time is UTC +12. It is fixed across the country.

7.4 Regular commercial business hours are from Monday through Friday from 0800 to 1700 hours and Saturday from 0800 to 1400 hours.

TAX AT AIRPORTS

7.5 No additional tax is collected at the airport. The taxes are included in the airfare.

TAXES AND TIPS

7.6 The tax on purchases is included in consumer prices. Tipping is not customarily required.

VISA REQUIREMENTS
