## ICAO LTAG NET-ZERO 2050

Long-term global aspirational goal for international aviation

At the ICAO Assembly in October 2022 member States agreed on a collective Long-term Aspirational Goal (LTAG) for international aviation of **NET-ZERO CARBON EMISSIONS BY 2050**, in support of the Paris Agreement's temperature goal.

This historic decision was supported by ICAO's technical work published in the **LTAG report**, describing increasing possible levels of ambition, with up to 87% of CO<sub>2</sub> reduction by 2050 from aircraft technology (21%), operations (11%), and fuels (55%).

In parallel, States and the industry have been implementing the **Carbon Offsetting and Reduction Scheme for International Aviation (CORSIA)**, which complements aviation's CO<sub>2</sub> reduction measures to achieve the ICAO aspirational goal of carbon neutral growth from 2020.

Achieving a just-transition towards net-zero carbon emissions requires substantial investment and financing, and concrete means of implementation. ICAO has launched its **Assistance, Capacity-building and Training for Sustainable Aviation Fuels (ACT-SAF)** programme to provide tailored support to States on SAF development and deployment.

The ICAO side event will discuss how ICAO and its Member States will work together with industry, civil society and other stakeholders to achieve its International Aviation's Net Zero 2050 goal.
