الموجز

يُقدّم في ورقة العمل هذه إسناد البند الخاص A1 إلى رقم الأمم المتحدة UN 2881. الإجراء المعروف على فريق خبراء البضائع الخطرة: يُرجى من فريق الخبراء أن ينظر في إسناد البند الخاص A1 إلى رقم الأمم المتحدة UN 2881 في الجدول (3-1) من "التعليمات الفنية" على النحو المبين في المرفق (A) وإلى الجدول (S-3-1) في الإضافة الملحقّة بوثيقة "التعليمات الفنية" على النحو المبين في المرفق (B) بورقة العمل هذه.

1. INTRODUCTION

1.1 UN 2881 — **Metal catalyst, dry**, Packing Group I is forbidden to be transported on both passenger and cargo aircraft and UN 2881 — **Metal catalyst, dry**, Packing Group II is forbidden to be transported on passenger aircraft. Special Provisions A3 and A36 are assigned to UN 2881:

1.2 Special Provision A36 specifies that the provisions of Special Provision A2 apply to the entry for Packing Group I only and the provisions of Special Provision A1 apply to the entry for Packing Group III only, yet neither A1 nor A2 is listed in the special provision field for UN 2881 as is the case for other substances which have A36 assigned. For example, Special Provisions A36 and A1 are assigned to UN 1228, UN 2030 and UN 3448.

A36 The provisions of Special Provision A2 apply to this entry for Packing Group I only and the provisions of Special Provision A1 apply to this entry for Packing Group II only, as applicable.

1.3 Table S-3-1 in *Supplement to the Technical Instructions for the Safe Transport of Dangerous Goods by Air* (Doc 9284SU) indicates that UN 2881 — **Metal catalyst, dry**, Packing Group I is forbidden for transport on both passenger and cargo aircraft, but provides a reference to Packing Instruction 473 for passenger aircraft for UN 2881 — **Metal catalyst, dry**, Packing Group II. This implies that Special Provision A1 should be assigned to UN 2881.
