#### **SPECIAL PROVISION A36**

(Presented by T. Muller)

#### **SUMMARY**

This working paper proposes to delete Special Provision A36 from UN 1228 and from UN 1963 and to simplify the text of Special Provision A36.

**Action by the DGP:** The DGP is invited to consider the amendments as proposed in the appendix to this working paper.

#### 1. **INTRODUCTION**

- 1.1 DGP/28-WP/30 presented by Mr. Guo proposes a correction to UN 2881 **Metal catalyst, dry** to remove the inconsistency with the assignment of Special Provision A36 to UN 2881. During the discussion of this working paper with some panel members, it became clear that the wording of Special Provision A36 is confusing.
- 1.2 Special Provision A36 applies to entries for which several packing groups exist and reads as follows:

The provisions of Special Provision A2 apply to this entry for Packing Group I only and the provisions of Special Provision A1 apply to this entry for Packing Group II only, as applicable.

This means that when Special Provision A36 is assigned to an entry, A1 and/or A2 should be assigned.

1.3 The UN numbers which have been assigned with Special Provision A36 are as follows:

- 1.4 From the list of entries assigned to Special Provision A36, the following conclusions can be made:
  - a) no entries that are assigned to Special Provision A36 are also assigned to both Special Provisions A1 and A2
  - b) including the proposal in DGP/28-WP30, five entries are assigned to both Special Provisions A36 and A1: UN 2881, UN 3448, UN 2030 and UN 1228 (including the entry for mixtures); and

c) one entry is assigned to Special Provision A36 and A2 only: UN 1693.

- 1.5 Based on the above, we believe that the following improvements and simplifications can be made to Part 3;2, Table 3-1 and to Part 3;3, Table 3-2:
  - a) remove Special Provision A36 assigned to UN 1693

Reason: Special Provision A2 applies only to cargo aircraft only. For UN 1693, only Packing Group I is forbidden on cargo aircraft only. Therefore, Special Provision A36, which identifies that A2 applies only to Packing Group I, becomes redundant.

b) remove Special Provision A36 assigned to UN 1228

Reason: UN 1228 only has Packing Group II and Packing Group III. Moreover, only Packing Group II of UN 1228 is forbidden on passenger aircraft which means that there is no need to identify by means of Special Provision A36 that A1 applies only to Packing Group II.

c) amend Special Provision A36 as follows:

"A36 The provisions of Special Provision A1 apply to this entry for Packing Group II only."

Reason: The following remaining UN numbers, UN 2881, UN 3448 and UN 2030 only have Special Provision A1 assigned which makes the reference to A2 for Packing Group I redundant.

By removing Special Provision A36 from UN 1693 and from UN 1228 and by modifying the text of Special Provision A36, the intent of Special Provision A36 will be better understood.
