# Agenda Item 2: Development of recommendations for amendments to the Technical Instructions for incorporation in the 2005/2006 edition

#### AMMUNITION, SMOKE, UN0015, UN0016 AND UN0303

(Presented by G. A. Leach)

#### 1. **INTRODUCTION**

1.1 An inconsistency has been noted in the Technical Instructions and Supplement when compared to the UN Recommendations. The entries for UN0015 Ammunition, smoke, 1.2G, UN0016 Ammunition, smoke 1.3G and UN0303 Ammunition, smoke 1.4G have a subsidiary risk of "8" and the consequent requirement for a "corrosive" hazard warning label. However, in the UN Recommendations, these entries do not necessarily possess a corrosive subsidiary risk, they are assigned special provision 204 which requires a "corrosive" subsidiary risk label only if the smoke producing substance meets the criteria of class 8. It is suggested the Technical Instructions and Supplement should align with the UN Recommendations in this respect.
