**2.8 : Part 8 — Provisions Concerning Passengers and Crew**

**SECURITY TYPE EQUIPMENT**

(Presented by B. Carrara)

**SUMMARY**

This paper proposes the exclusion of security type equipment from the text of Part 8;1.1.1.

Action by the DGP-WG is in paragraph 2.

**1. INTRODUCTION**

1.1 The carriage of security-type equipment such as attaché cases, cash boxes, cash bags, etc. by passengers or crew is forbidden in accordance with Part 8;1.1.1.

1.2 On the other hand, the 2011-2012 Edition of Technical Instructions introduced a provision to carry this equipment in Part 8;1.1.2 y) of that edition (Table 8-1, item 30) of the current edition..

1.3 Since the Technical Instructions provide a mechanism to carry these items in Table 8-1, they are no longer “totally forbidden”. There is therefore no reason to maintain them as forbidden in paragraph 1.1.1 of Part 8.

1.4 If security-type equipment was kept in paragraph 1.1.1 of Part 8, all other items shown on Table 8-1 should be forbidden too, but that would not make sense.

**2. ACTION BY THE DGP-WG**

2.1 The DGP-WG is invited to delete security type-equipment from Part 8;1.1.1 as shown in the appendix of this working paper.

**Chapter 1**

**PROVISIONS FOR DANGEROUS GOODS  
CARRIED BY PASSENGERS OR CREW**

*Parts of this Chapter are affected by State Variations CH 1, US 15; see Table A-1*

**1.1 DANGEROUS GOODS CARRIED BY PASSENGERS OR CREW**

1.1.1 Except as otherwise provided in 1.1.2, dangerous goods, including excepted packages of radioactive material, must not be carried by passengers or crew members, either as or in carry-on baggage or checked baggage or on their person. ~~Except as provided for in Table 8-1, 30), security type equipment such as attaché cases, cash boxes, cash bags, etc., incorporating dangerous goods, for example lithium batteries or pyrotechnic material, are totally forbidden; see entry in Table 3-1.~~ Personal medical oxygen devices that utilize liquid oxygen are forbidden either as or in carry-on baggage or checked baggage or on the person. Electroshock weapons (e.g. tasers) containing dangerous goods such as explosives, compressed gases, lithium batteries, etc., are forbidden in carry-on baggage or checked baggage or on the person.

1.1.2 Notwithstanding any additional restrictions which may be implemented by States in the interests of aviation security, except for the incident reporting provisions of 7;4.4 or 7;4.5, as applicable, the provisions of these Instructions do not apply to the following when carried by passengers or crew members or in baggage that has been separated from its owner during transit (e.g. lost baggage or improperly routed baggage) or in excess baggage carried as cargo as permitted by 1;1.1.5.1 g):
