Survey Objective





A total of thirty two training courses and workshops were delivered and considered in the survey in the following fields:-






Geographical Distribution of Respondents







Overall Analysis



Capacity Building

- Poor participation due to budget constraints within some States, unawareness of training event(s) and lack of related courses in French language.
- Knowledge gained enhanced implementation of ICAO provisions and Capacity building within States

Training programme

- Review entry requirements for GSI courses to accommodate new inspectors and introduce annual refresher courses
- Initial GSI Courses should be held annually in both languages (English and French).

Feedback on Courses

- Open courses to operators and service providers to enable a better understanding of ICAO provisions by the industry
- Course material is very comprehensive hence recommendation for allocation of additional time per session



ASSOCIATION OF AFRICAN AVIATION TRAINING ORGANIZATIONS (AATO)

Special AFI RAN Recommendation 5/8



Recommendation 5/8 – Training Strategies for safety in Africa:

"That,

□ ACIP, in cooperation with AFCAC and other stakeholders organize Pan African Training Coordination Conferences that will serve as the framework for closer cooperation and harmonization of training requirements as well as standardization and quality assurance;

□ the First Pan-African Training Coordination Conference form a working group of training experts to define a master plan for harmonization of training in the AFI Region;

Pan African Training Coordination Conferences



First Pan-African Aviation Training Coordination Conference, Niamey, 17-19 February 2009

- Initiated the process of implementing Recommendation 5/8 of Special AFI RAN
- Laid the foundation for the development of a framework for closer cooperation and harmonization of training requirements as well as standardization and quality assurance

Second Pan-African Aviation Training Coordination Conference, Cairo, 22-24 June 2010

- Received the Report of the Training Experts Working Group
- Adopted a common strategic framework and action plan conceived to improve the availability of affordable and quality training programmes, harmonized and standardized throughout Africa, while promoting a common African Aviation training accreditation system recognized around the world

Third Pan-African Aviation Training Coordination Conference, Cape Town, 27-29 July 2011

- Reviewed the implementation of the action plan adopted by the 2nd Pan African Aviation Training Coordination Conference
- Developed a framework for harmonization of aviation training in Africa

Outcomes of the consultative assembly on AATO, 2 to 4 April 2012



The Conference reviewed and made recommendations on:

The Draft constitution of the Association of African Aviation Training Organizations (AATO);

The draft organizational structure of the AATO;

The initial list of activities of the AATO that require financial consideration in finalization of the Business Plan 2012-2016 of the Association

The Conference further appointed an interim Council to further pursue the activities towards the finalization of the establishment of the AATO to:

Distribute all the documentation among all the potential members,

Conduct the formal constitutive assembly leading to the signature of the Constitution by the founding members;

Carry out Membership drive;

Oversee the establishment of the Secretariat and prepare the Business Plan

Facilitate the election of the Council in line with the Constitution.

Constitutive Assembly scheduled for 10-12 April 2013 in Abuja, Nigeria

Special AFI RAN Recommendation 5/13 and 5/14



Recommendation 5/13 - Follow-up and continuous monitoring of the sustainability of implementation projects:

"That Regional Office Safety Teams (ROSTs) be established in the AFI Region to ensure the continuity of the ACIP Programme and to follow up and continuously monitoring the effectiveness and sustainability of implementation projects."


Recommendation 5/14 - Establishment of complementary safety teams:

"That Safety Teams be established by States, COSCAPs, and other Regional Aviation Safety Agencies in the AFI Region to complement and work closely with the ICAO Regional Office safety Teams." RASG established in March 2012

ICAO PLANS OF ACTION



Immediate Term:

- Address the major safety deficiencies
- Regional Office Safety Teams (ROSTs) and/or AFCAC Cooperative Inspectorate Scheme (AFI-CIS)

Near Term

- Continuation of the implementation of the State's Corrective Action Plan (CAP) to address the remaining deficiencies
- Mostly AFI-CIS

Long Term

- Continue to monitor the situation on an on-going basis to promote aviation safety
- Ensure that the State maintains its ability to comply with safety oversight requirements.
- Mainly through projects (TCB or any other arrangements by the State)





Lack of Effective Implementation by AREA Madagascar (CSA Audit LEI: 71%)





ICVM Results: MAURITANIA Performance by Audit Areas











ICVM Results: RWANDA Performance by Audit Areas







ICVM Results: SUDAN Performance by Audit Areas








- > ICVM conducted on 11–15Dec. 2011 (initial) and a 16–19 May 2012 (follow-up)
