#### SIASA


- Support to the Improvement of Aviation Safety in Africa
- Ended mid October 2016

#### CAASP

- Central Africa Aviation Safety Project
- Closing at the end of 2017


#### **IASOM**

- Improvement of Aviation Safety Oversight in Malawi
- Closing in June 2017





### Drawing lessons - SIASA



➤ Assistance to specific States, provided, some of which have been removed from the EU Safety List such as Benin and Mozambique in May 2017


 The RSOOs supported have shown increased maturity

Some training has been delivered but remains still a major need. It is however time to provide sustainability to these efforts



### Drawing lessons - CAASP

- ➤ Regulation in the domains of PEL, OPS, AIR & AGA is ready to be adopted at a regional level
- ➤ Operationalisation of the RSOO moved slower than expected
- ➤ Effective collaboration with ACI for APEX in Safety review of main airports in the region
- ➤ It is time to act now at the political level now





### Drawing lessons - IASOM



- ➤ Right from the beginning EASA invited the ESAF office to take an active role in the project
- ➤ Adopting Primary Aviation Law takes sometimes longer than expected – not achieved yet
- ➤ The priority for the country is the adoption of new Civil Aviation Act drafted in the framework of the project
- ➤ Most of the open PQs were reviewed in the course of the project.
- ➤ Malawi is today the country in Africa closest to resolving its SSC



### Regional approach for safety



#### The RSOO Forum addressed issues such as:

- Benefits and challenges of the regional approach
- Financial aspects and sustainability
- Pooling of resources, processes and staff

#### EASA supports this regional approach

- Work on setting up the RSOO platform
- Support ICAO with the implementation of the Forum's outcome
- Use the RSOO channel to streamline the assistance provided



# Future Projects in the pipeline

#### **EU-ASAP**


- Follow-up of the SIASA project
- To start early 2018
- Major focus on RSOOs and regional entities

#### Zambia

- Continuation of previous project which saw the country removed from the EU Safety List in 2016
- To start in 2017

#### **SATSD in EA-SA-IO**

- Support to Air Transport Sector
   Development (SATSD) in the Eastern Africa,
   Southern Africa and Indian Ocean region
- Still in the early definition phase





### Concluding remarks (1/2)

- Sustainable approach preferred
  - Priority on train-the-trainer
  - Move from theoretical toward on the job training
  - Support South to South initiatives/solutions
- Coordination needed
  - To deliver qualitative projects
  - To avoid duplication between projects and misuse of funds
