 FAA's goals and objectives are developed in consultation with key African States and stakeholders, as well as ICAO's AFI Plan and Abuja Safety Targets.

FAA's key objectives are:

- FAA's Flight Standards Service: providing technical assistance and training to advance compliance with ICAO SARPS

 – Annexes 1, 6, and 8.
- FAA's Air Traffic Organization: improving CNS/ATM in Africa to achieve seamless, harmonized global operations.
- FAA's Air Traffic Safety Oversight Service: increasing effective implementation of ICAO SARPs by sharing implementation strategies with states for conducting effective oversight of ANSPs.
- FAA's Airports Organization: reducing runway incursions and excursions, mitigating wildlife hazards, managing pavement maintenance, and planning aerodrome emergency response mechanisms.
