EXECUTIVE SUMMARY

This paper presents information on the status of implementation of the Decisions and Recommendations of the 19th meeting of the AFI Plan Steering Committee held on 23 May 2017 in Gaborone, Botswana as well as the 2017 AFI Plan work programme.

Action: The Steering Committee is invited to:

- a) Note the information contained in the paper;

- c) Provide further instructions and guidance for the continued implementation of the Decisions and Recommendations of its 19th meeting, considering the status of implementation (column 7 of **Attachment A**); and
- d) Provide further instructions and guidance for the continued implementation of the 2017 Work Programme considering the status of implementation (Column 4 of **Attachment B).**

1. INTRODUCTION

1.1 The Steering Committee at its 19th meeting had reviewed the actions undertaken since its eighteenth meeting on the implementation of the AFI Plan and in so doing, took some additional Decisions and made Recommendations on the 2017 Work Programme.

1.2 This paper summarizes the progress made in the implementation of the Decisions and Recommendations of the 19th meeting of the AFI Plan Steering Committee and the status of implementation of the 2017 Work Programme.

2. SUMMARY OF IMPLEMENTATION PROGRESS: JUNE - DECEMBER 2017

2.1 The list of Decisions and Recommendations of the 19^{th} meeting of the AFI Plan Steering Committee (SC/19) along with an update on actions undertaken and / or required from this meeting are attached herewith as **Attachment A**. Similarly, the progress made so far in implementing the 2017 Work Programme is presented as **Attachment B** to this Discussion Paper.

2.2 With regards to Regional Safety Oversight Organizations (RSOOs) and Regional Accident Investigation Organizations (RAIOs), efforts to strengthen and operationalize such entities are continuing. Accordingly and n in line with the Ezulwini Declaration on RSOOs adopted on the 24th of March 2017 by African Ministers responsible for Civil Aviation, and the subsequent Decision by the 19th meeting of the AFI Plan Steering Committee adopting the Terms of Reference for the development and implementation of a Strategic Plan to support and strengthen RSOOs in the Region, steps are being taken to engage a suitable consultant for the purpose.

2.3 The implementation of AFI Plan projects approved at the 17th SC meeting is progressing. The implementation status of each project is to be presented to this meeting in **DP-02.** Furthermore, in accordance with the Decision of the 19th SC meeting two (2) additional projects required to build capacity and assist States in the areas of Aircraft Accident investigation (AIG) and Fundamentals of safety oversight (FSO) have been prepared and will be presented in **DP-07** for your consideration.

2.4 On the basis of the Recommendation of the SC/19 meeting, the proposed revised Abuja Safety targets and Air Navigation Performance Indicators and Targets were presented to the 4^{th} RASG-AFI and 21^{st} APIRG meetings for approval. The consolidated set of proposed revised targets presented to these two Groups were reviewed and approved with some amendments and recommendations. These inputs have now been taken in to account in an updated version of the proposals to be submitted to this meeting as DP-03, for consideration.

2.5 The AFI Plan Secretariat continues to provide support to the AATO. In this regard, the AFI Plan Secretariat participated in the 12th AATO Council meeting and provided additional information required to finalize the Aviation Training Roadmap for Africa. The detailed progress report on the review and finalization of the roadmap will be presented to this meeting, by AATO, as DP-04.

2.6 As envisaged in the ICAO Plans of Action (for 36 States to date), collaboration is ongoing between ICAO and AFCAC (AFI-CIS), RSOOs and COSCAPs, as well as other partners, to provide assistance to African States in addressing safety deficiencies identified through the ICAO Universal Safety Oversight Audit Programme (USOAP).

2.7 The Regional Office Safety Teams (ROSTs) have been active in assisting States in the implementation of their Corrective Action Plans (CAPs) prepared in response to deficiencies identified by ICAO USOAP Audits. Accordingly, in 2017 ROST missions were conducted to 16 States (namely; Angola, Malawi, Burundi, Djibouti, Rwanda, Swaziland, 2.8 The increased assistance and engagement with States resulted in a corresponding improvement of EIs in both ESAF and WACAF regions. Accordingly, in 2017 an increased number of States notably Tanzania, Rwanda, Chad, Congo, Mozambique, and Benin have each shown good progress in improving their EI levels while Djibouti and Angola were able to resolve their long standing SSCs. In addition, a good number of States have shown improved CAP implementation progress as determined through updates provided on the USOAP CMA Online framework (OLF).

2.9 High-level engagements continued with African States including those countries with low EIs and slow progress in the implementation of their ICAO Plans of Action. In this regard, in 2017, the President of the ICAO Council and Secretary General held side meetings with States at various events such as the ICAO/EASA Forum on RSOOs (Ezulweni, Swaziland, March 2017), the 2nd ICAO Sustainable Development of Air Transport in Africa meeting (Accra, Ghana, March 2017), the High Level Conference for the Improvement of Search and Rescue in Africa (Lomé, Togo, April 2017), African Union Assemblies, the ICAO GAT TRAINAIR PLUS Symposium (Addis Ababa, Ethiopia in April 2017), 4th Aviation Week (Gaborone, Botswana) and the recently concluded Third ICAO World Aviation Forum (Abuja, Nigeria 20-22 November 2017).

2.10 The support from the United States Department of Transportation Safe Skies for Africa (SSFA) Program and the Federal Aviation Administration (FAA), the EU funded projects as well as other partners, aimed at assisting African States in improving the level of implementation of ICAO safety standards, is on-going. The meeting will be provided with more detailed information on the various initiatives during the session on Presentations by Partners.

2.11 The Secretariat continued to collaborate with ICAO-endorsed Aviation Training Centres such as the Air Traffic and Navigation Services (ATNS) Academy in Johannesburg, South Africa; the East African School of Aviation (EASA), Nairobi, Kenya; Ecole Africaine de la Météorologie et de l' Aviation Civile (EAMAC), Niamey, Niger and Ecole Régionale de la Navigation Aérienne et de Management (ERNAM), Dakar, Senegal, on the preparations, organization and delivery of essential aviation safety training courses to member States. These training centres have been conducting ICAO Government Safety Inspector (GSI) courses on Personnel licencing, Airworthiness of aircraft and Aircraft operations as well as Inspector courses on Air Traffic Management, Communications, Navigation and Surveillance and Meteorology.

2.12 With respect to the three key AFI Plan goals targeted for December 2017 i.e. 60 % EI for 80 % of the States, zero SSCs and certification of at least 45% of international Airports, the situation as at 1 December 2017 is as follows;

- Twenty-Nine States (56 % of USOAP Audited African States) have attained 60% EI
- Two (2) SSCs remain unresolved in 2 States, namely Eritrea and Malawi; and
- A total of 24 % International Airports have been certified.
