



USOAP Findings, 24 March 2009 Critical Elements – Lack of Effective Implementation





Critical Element 3 – Civil Aviation System and Safety Oversight Functions





Training and qualification

- No industry, can survive, let alone achieve its goals, unless it is staffed by appropriately trained and qualified personnel;
- Training and qualification of personnel is the foundation upon which successful organizations are built;

Training and qualification

 Safety and efficiency of international civil aviation depends primarily on the skills of and qualification of the personnel that manage, operate and maintain its system.

Training and qualification

- Professionals must not only possess high individual skills and qualifications but must also be able to work together as a team;
- It is no different for training centres especially in Africa because of the need for appropriately trained and qualified aviation experts.

So! What are the challenges?

ONE MAJOR CHALLENGE !!!

- Our ability to work together to overcome the deficiency in the availability of appropriately trained and qualified aviation personnel in Africa.
- This includes the ability to attract, recruit and retain qualified personnel.

Further AFI-RAN recommendations

- ... training needs analysis and States' human resource plans would establish a strategic plan to increase, as well as rationalize training resources within Africa;
- States and donors consider reinforcing the capacity of existing training centres.

Objectives of this conference

- Provide the platform for African Training Institutes to openly discuss the recommendations and initiate the development of a coordinated training policy with standardized courses, and increased cooperation between them;
- In brief, to design the means for the implementation of recommendations of the Special AFI RAN Meeting.

- Panel Three to investigate possible venues for better cooperation among African training institutes, initiate the development of a global training policy for aviation training in Africa;
- Moderated by Dr. Getachew Biru, EAA
- Participants expected to discuss and assess the information presented, determine the way forward, elect members of the Working Group and determine the Terms of reference of the Working Group.
