Subject: Establishment of the Voluntary Air Transport Fund

Action required: Contributors are encouraged to make voluntary contributions to the Fund

Sir/Madam,

I have the honour to inform you that the ICAO Council, at the second meeting of its 201st Session, approved the establishment of the Voluntary Air Transport Fund (TRAF), as recommended by the Sixth Worldwide Air Transport Conference, in support of the Organization's work in the air transport field. In the past, ICAO established extra-budgetary funds for specific emerging priorities, notably safety, security, and environmental protection. The creation of a similar air transport fund would allow a streamlined administration of donated funds and timely execution of air transport activities not covered by the Regular Programme Budget under the new Strategic Objective, *Economic Development of Air Transport*.

The TRAF will be subject to the administrative and programme controls of the ICAO Voluntary Fund Guidelines and the ICAO Financial Rules and Regulations. A list of tasks that may be undertaken by using contributions from the Fund is provided in Attachment A.

Participation in the TRAF is financially independent of the ICAO Regular Programme Budget. Contributions to the Fund can be made by ICAO Member States, international organizations, and public and private entities associated with international civil aviation. Donor's contributions may be earmarked for a specific project or objective, while general contributions (un-earmarked) will be used as deemed appropriate and necessary.

To support ICAO in carrying out the wide-ranging tasks that would benefit the development of global air transport, I appeal to Member States and all interested donor parties to contribute to the ICAO TRAF. Contributions may be made by cheque payable to ICAO or by electronic bank transfer (instructions for the transfers are given in Attachment B). ## ESTABLISHMENT OF THE VOLUNTARY AIR TRANSPORT FUND

Possible tasks to be undertaken by ICAO under the voluntary contributions of the air transport fund:

- a) consider additional ways and means by which to enhance the status of ICAO's policies for the sustainable economic development of the air transport system, and assess the value of a possible new Annex to the Chicago Convention on sustainable economic development of air transport, or other acceptable solutions;
- b) take necessary action for subsequent work on cost-benefit analysis related to air transport connectivity;
- c) study and develop guidance on any other important issues that may arise as liberalization progresses;
- d) promote and assist with the ratification of the *Convention for the Unification of Certain Rules for International Carriage by Air* (Montréal Convention 1999); and
- e) conduct econometric studies and develop a monitoring system designed to explain the effects of the liberalization on international traffic and assess its evolution, taking into account all the variables involved in the liberalization process.
