1. SITE OF THE WORKSHOP

1.1 The workshop will be held at Khreshchatik 2 str., "Ukrainian House" Kyiv, Ukraine. The opening of the workshop is planned at 1000 hours.

1.2 **Registration**

Registration of participants will be at 0900 hours.

2. **HOTELS**

2.1 Participants are requested to make their own hotel reservations. A list of recommended hotels will be sent to you separately.

3. CLIMATE

3.1 The mean minimum temperature during the month of June is 22°C and the mean maximum temperature is 30°C. The mean relative humidity is 70 per cent. The month of June is relatively dry with a mean of about 2-3 rainy days.

4. **HEALTH**

- 4.1 Vaccinations? Not necessary.
- 4.2 Infirmary. There are enough of easily accessible hospitals, first-aid posts and polyclinics.

5. **CURRENCY**

- 5.1 The basic unit of currency is the Hryvna, which is divided into 100 kopiyok. There are coins of 1, 2, 5, 10, 25, and 50 Hryvna. Notes are issued in denominations of 1, 2, 5, 10, 20, 50, 100, and 200.
- 5.2 The commercial banks in the city centre provide exchange facilities. Most banks are open between 10.00 a.m. and 6.00 p.m. from Monday to Friday.
