I have the honour to invite your Administration to participate in a regional workshop for the Americas on airport and route facility management which ICAO is holding in Montreal from 15 to 19 April 2002.

Two non-Contracting States will also be invited to send participants, i.e. Dominica and Saint Kitts and Nevis. Additionally, the Airports Council International (ACI), the Central American Corporation for Air Navigation Services (COCESNA), the International Air Transport Association (IATA), the Latin

American Civil Aviation Commission (LACAC) and the Latin American International Air Transport Association (AITAL) are being invited to attend.

Following the pattern established for such workshops, the agenda will be as follows:

- 1. ICAO policy on airport charges
- 2. Organizational structures of airports, including commercialization
- 3. Airport financial management
- 4. Airport charges on air traffic and their collection
- 5. Development and management of non-aeronautical activities
- 6. Infrastructure financing
- 7. ICAO policy on air navigation services charges
- 8. Organizational structures of air navigation services, including international cooperation
- 9. Financial management of air navigation services
- 10. Air navigation services charges and their collection

Special attention will be given to the implementation of recommendations of the Conference on the Economics of Airports and Air Navigation Services (ANSConf 2000), held in Montreal 19 to 28 June 2000, including privatization and cooperative ventures as well as general cost recovery issues.

These workshops are intended to be informal meetings providing a forum for participants from States to receive advice and freely exchange views and information on economic aspects of the operation and management of airports and route facilities (and air navigation services in general), so as to encourage consistency and standardization in implementing decisions and recommendations arrived at by Contracting States in formal ICAO meetings (such as ANSConf 2000). Those participating should come prepared to discuss any problems relating to such matters as well as possible solutions, in an informal and practical way.

It should be emphasized that representatives of autonomous entities (public as well as private) for airports and air navigation services in your State are welcome to participate in these workshops. The participation of such entities is in the interest of States with respect to their obligations under the *Convention on International Civil Aviation* in Doc 7300 (the Chicago Convention), and will further increase the dissemination of ICAO policy and guidance. As invitations to ICAO workshops are addressed to States, you are encouraged to bring this invitation also to the attention of any autonomous entities established in your State and to include them in your participation where possible.

There is no attendance fee and the most essential meeting documentation will also be provided by ICAO free of charge (the *Airport Economics Manual* (Doc 9562) and the *Manual on Air Navigation Services Economics* (Doc 9161/3)). Some of the ICAO publications that will be used during the workshop are available via the ICAO web site **http://www.icao.int** and the participants should therefore provide themselves with copies of these documents and bring them to the meeting. This is applicable to the following documents: *ICAO's Policies on Charges for Airports and Air Navigation Services* (Doc 9082/6), the *Report of the Conference on the Economics of Airports and Air Navigation Services* (Doc 9764, ANSConf 2000) as draft report material, and the *Report of the World-wide CNS/ATM Systems Implementation Conference* (Doc 9719). To access these publications see guidance in Attachment A. The distribution of other reference documents will be limited to one per delegation, but attendees who may wish to purchase copies of the relevant publications (either prior to the meeting or at the ICAO Headquarters during the meeting) will be accorded a 50% discount by quoting the reference number of the meeting when

ordering. A complete list of ICAO publications used as reference documents for the meeting is in Attachment A.

Travel and daily subsistence costs for participants are the responsibility of the nominating Administration, or the autonomous entity, if applicable. Participants with a satisfactory level of attendance in the workshop will be awarded an ICAO certificate.

The working languages of the workshop will be English and Spanish. In accordance with the Council's guidelines for the conduct of such workshops, ICAO Secretariat working papers for the meeting will be kept to a minimum. Such papers will consist of explanatory notes on the agenda and a few other working papers which will be distributed subsequently. Some working papers, as well as this letter of invitation, will be accessible under the *Meetings* heading of the ICAO website <a href="http://www.icao.int">http://www.icao.int</a>. Participants having points of interest or information relating to the agenda are encouraged to prepare informal working papers not exceeding three pages on such matters for the workshop and, to ensure their timely distribution to other participants, should forward these to reach me as soon as possible, and in any event not later than 2 April 2002. Such working papers, as well as those prepared by the Secretariat, are intended solely to facilitate discussions at the meeting and will not be given general distribution outside the workshop.

In order that further planning for the meeting may proceed in good time, I would very much appreciate your letting me know by **not later than 2 April 2002** whether or not your Administration intends to participate in the workshop, and if it intends to participate, at the same time also advise me of the names and official positions of those who will be attending, including participants from autonomous entities.

The workshop will convene in Conference Room 5 at the ICAO Headquarters, Montreal, with its opening meeting commencing at 1000 hours on Monday, 15 April 2002. Registration will take place from 0900 to 1000 hours. At registration, participants will be issued an identification badge which will be required to access the Conference Centre.

A list of suggested hotels, their rates and other relevant information is contained in the Attachment B. Participants should contact the hotel of their choice directly for reservation purposes.


